If you are not certain of the model of your phone, refer to your original receipt or you may be able to determine the model by following these steps: Turn your phone's power off. Carefully remove the battery cover and the battery. The model is typically printed on the white label located under the battery.

Important: Customers with losses on phone models in Equipment Tier 2 starting April 19, 2009 will be processed at the **\$100.00 non-refundable deductible**, regardless of the date the phone was purchased.
